Ride/Critique/Ride times will be scheduled at 30 minutes each. Ride the test, receive a critique, ride the test. First ride score to count toward class placing.

Awards: Ribbons awarded to 8th place, special prize to first place.

Releases: Riders must have a Mystic Valley Hunt Club, Inc. Waiver & Medical Form on file. If you need one, it can be emailed to you upon request.

Test Pick up: After class is scored and placed, tests will be on a table with your ribbon & award by secretary.
