I agree to indemnify (that is, to pay any losses, damages or costs incurred by) the competition, the management, Mystic Valley Hunt Club, Inc. the affiliated Associations, CHJA, CHSA, NEHC, and M&S, and to hold them harmless with respects to claims for harm to me, my horse, and/or my property and from any harm caused by me or my horse to others at the competition. If I am a parent or guardian, or a trainer of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions and agree to assume all of the obligations of this release on the child's behalf. Every exhibitor and his/her agent and trainer must sign an entry form. In the event of his failure to do so, his first entrance on to the grounds shall be construed as acceptance for the rules of the show, the affiliate organizations, and Mystic Valley Hunt Club, Inc. No entry is permitted into the ring that is ineligible for competition.
